#### Stated Objective

To represent large and well-known U.S. companies. Covers all industries with the exception of Transportation and Utilities.

#### **Key Features**

- Components are selected by an Averages Committee comprised of the Managing Editor of The Wall Street Journal, the head of Dow Jones Indexes research and the head of CME Group research. The Averages Committee was created in March 2010, when Dow Jones Indexes became part of CME Group Index Services, LLC, a joint venture company owned 90% by CME Group Inc. and 10% by Dow Jones & Company.
- The index is price weighted.
- The Dow Jones Industrial Average<sup>SM</sup> was first calculated on May 26, 1896.
