



# iShares S&P Global Consumer Staples Sector Index Fund

# **Fund Description**

The iShares S&P Global Consumer Staples Sector Index Fund seeks investment results that correspond generally to the price and yield performance, before fees and expenses, of companies that Standard & Poor's deems part of the consumer staples sector of the economy and important to global markets, as represented by the S&P Global 1200 Consumer Staples Sector Index™ ("the Index"). The index is a subset of the Standard & Poor's Global 1200 Index.

# **Index Description**

The Index includes manufacturers and distributors of food, producers of non-durable household goods, and food and drug retailing companies. With the exception of the U.S., all companies are float adjusted and reconstitution is a continuous process.


