## **KBC to call outstanding stock of classic Tier-1 securities after successfully closing its AT-1 issue**

Following the successful closure of its AT-1 securities issue and the listing of the securities on Euronext Brussels on 19 March, KBC confirms today that it will call 5 outstanding classic Tier-1 securities on their next call date.

**Johan Thijs, KBC Group CEO** commented on the call decision as follows: *'Our successful AT-1 issue enables us to further optimise our capital structure by replacing our classic Tier-1 instruments with more efficient and fully CRD IV compliant capital, while at the same time enhancing our total capital ratios under the new regulations and substantially reducing future interest charges.'*
